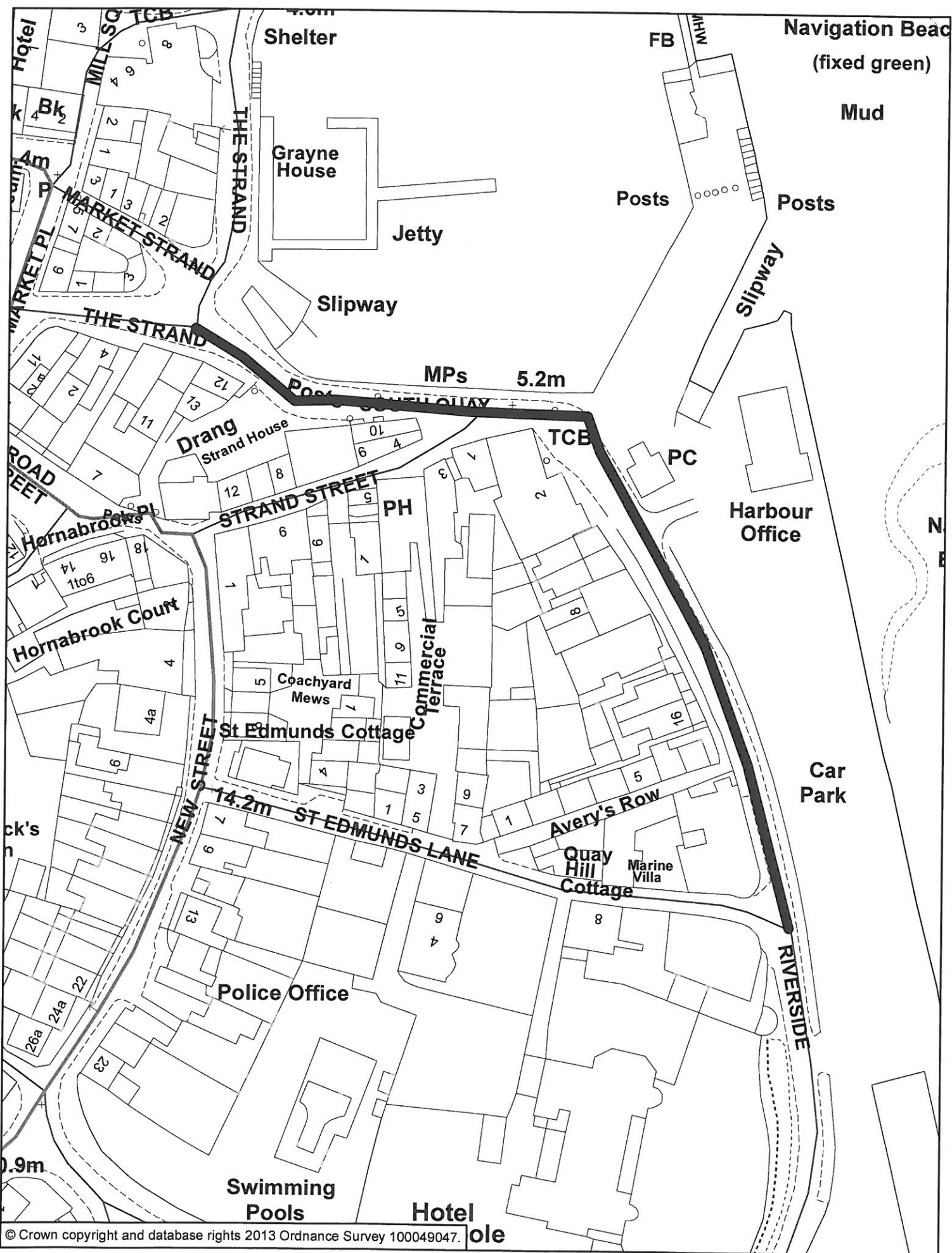


Temporary Road Closure

**Notice is hereby given** that Cornwall Council has made the above Order dated 18<sup>th</sup> November 2013 prohibiting the use by vehicular traffic of the undermentioned lengths of road at Padstow. This restriction is necessary for Padstow Christmas Festival. Exemptions are provided in the Order for emergency vehicles. It is expected that the Order will be in effect from 6<sup>th</sup> December 2013 (1200 hours) to 8<sup>th</sup> December 2013 (1630 hours)

**The County of Cornwall (Various Roads Padstow) (Special Events)**  
**(Padstow Christmas Festival) Order 2013**

**Whereas** Cornwall Council (hereinafter called "the Council") is the Traffic Authority for the Various Roads in Padstow in the said County

**And Whereas** the Council is satisfied that vehicular traffic on the said roads should by reason of Padstow Christmas Festival be prohibited and that exemptions are provided in the Order for emergency vehicles

**And Whereas** the Council is satisfied that a suitable alternative route exists for traffic affected by the Order

**It Is Hereby Ordered** in pursuance of Section 16(A) of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Special Events) Acts 1994 that use by vehicles, except upon the direction or with the permission of a police constable in uniform of (Riverside Padstow for its entire length and South Quay Padstow between the junctions of Riverside and The Strand) be prohibited and that this order take effect from 6<sup>th</sup> December 2013
