It was **PROPOSED** by Cllr Rickard and **SECONDED** by Cllr Mrs Davis that the Committee **RECOMMENDS** to full Council that £14,000 is awarded to the Skate park subject to the Trustees providing a written breakdown of all project funding. The funds to be drawn from the General Reserve and £7,000 of the £14,000 to be

repaid to the Council over a 10 year term. This proposal received unanimous support.
